Equipment such as telephones, fax and copier will be provided. Advance reservations are required.

**Broadcast Media:** Accredited TV and radio personnel, those affiliated with major independents, networks or national cable outlets, will be afforded live and taped broadcast opportunities and access to the media area. Segments must be limited to no more than three (3) minutes in length and be news-related. Non news-related usage is prohibited without prior written permission by International Management Group (IMG), which own the broadcast rights to the Go211 Live et al.
